9. Program: Jim Edwards introduced David Ewing who talked about the importance of the Rotary Club Foundation.

◆ Mr. Ewing was owner and operator of Ewing Chevrolet in downtown Canton and attended his first Rotary Club meeting when he was 29 years of age. He served as District Governor in 1989. Also, his father has been a Rotary Club member for almost 62 years!

◆ ◆ The Rotary Foundation supports the efforts of Rotary International to achieve world understanding and peace through international humanitarian, educational, and cultural exchange programs. It is supported solely by voluntary contributions from Rotarians and friends of the Foundation who share its vision of a better world (Wikipedia).

◆ Mr. Ewing encourages everyone to consider making a contribution to the Rotary Foundation even if your contribution is small at first. If everyone Rotarian donated \$100.00 per year, the Rotary Foundation would yield an incredible \$63 million annually. Remember that 50% of the funds donated to the Rotary Foundation returns to the district from which it was received.

◆ Mr. Ewing indicated that those persons who donate \$1,000 or more to the Rotary Foundation or to PolioPlus can be recognized as a Paul Harris Fellow. Friends, colleagues, and family members may also donate \$1,000 to honor a Rotary Club member.

◆ Philanthropist Bill Gates is pledging \$355 million to the PolioPlus initiative to eradicate polio worldwide. Rotary International is currently raising its matching amount of \$200 million. Mr. Ewing indicated that our Rotary Club goal is to raise \$500.00 toward the PolioPlus initiative.

◆ Rotary members can also purchase an Ohio automotive license plate in which \$25.00 will be donated to the Rotary Clubs of Ohio. A total of \$90,000 has been raised so far through this effort.

◆ Rotary members can also designate a sum of money to the Rotary Club through an insurance policy.

◆ **Sign projects report** ◆ Jim Edwards reported that placing service club and church emblems on four signs throughout the community is a huge project.

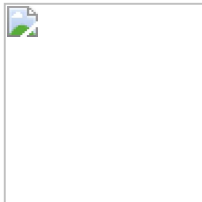
Mr. Edwards will research a more modest sign design and will report back to the Rotary Club in the near future.

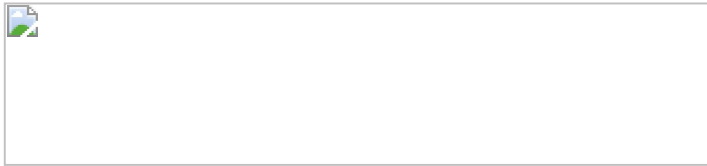
7. Old Business

8. Program ♦

Mike Snyder delivered a talk about the Best Friends Animal Society which is located in southern Utah. This past February, Mike and his wife Ellen journeyed to Best Friends to see for themselves this unique institution. Additional highlights of his presentation are as follows:

1. Best Friends Animal Society is one of America's best known animal welfare rescue groups. Best Friends works in outreach programs with shelters, other rescue groups and members nationwide to promote pet adoption, spay-and-neuter services, and humane education programs around the country.
2. Best Friends maintains the nation's largest no-kill safe haven for displaced, homeless or unwanted domestic animals, located in Southwestern Utah near the town of Kanab.
3. Best Friends is a sanctuary to about 1,700 animals, most of which are dogs and cats but also horses, burros, rabbits, goats, birds, and pot-bellied pigs.
4. Best Friends advocates for homeless pets throughout America and has been active in animal rescue projects, mainly in New Orleans after Hurricane Katrina. About 6,000 animals were rescued and treated over the past few years and many have been reunited with their families.
5. Best Friends took in 22 of the Michael Vick fighting dogs. A few of these dogs have been adopted out but most will spend the remainder of their lives in a pleasant setting with plenty of food, exercise, affection, and medical care.
6. Best Friends strongly opposes Puppy Mills, such as the ones now prevalent in nearby Holmes County, Ohio. Rather than purchasing a pet from a chain store, they recommend adoption from a local Humane Society shelter or purchasing a healthy, well-loved pet from a dealer registered through the American Kennel Club (AKC).
7. The Best Friends magazine is an excellent way to keep up with the news of the Sanctuary as well as to keep in touch with the animal rescue developments throughout the country.
8. In closing, Mahatma Ghandi remarked that The greatness of a nation and its moral progress can be judged by the way its animals are treated.

Jerry Dunbar ♦ He is a 1962 graduate of the Louisville High School and holds a bachelor♦s degree from Ashland University. Jerry taught earth sciences for many years in the Mansfield, Ohio, school district and enjoyed his time as a coach and athletic director. He retired in 2007 and moved back to this community where is 100-year old Mother still lives and thrives!

Barry Gray ♦ He is a native of Salem, Ohio, and is a graduate of Bowling Green State University. Following a 23-year stint in banking, Barry moved to the Edward Jones company, a firm that specializes in handling investments and retirement planning. He has twin sons and is still remembered for his wrestling prowess many, many years back at a Louisville High School tournament.

Bob Hallier ♦ He has lived in Louisville for 35 years and has four children. He was VP for Business and Finance at Stark State and was affectionately known as ♦ Bob the Builder ♦ because the campus literally exploded with growth during his long tenure there. His wife and he love to travel and speak very highly of their favorite Canadian destinations and of the Gulfshores of Alabama.

Ted Street ♦ He is a 1967 graduate of Louisville High School where we wore #21 while playing football. Ted is the son of two teachers and his son

attends Slippery Rock State University and his daughter attends The Ohio State University. He has owned and operated Main Street Tours for the past 24 years and continues to love golf, biking, fishing, and, oh yes, travel.

As Chairperson of the Fund Development & Capital Projects, Greg Anderson spoke at length about a possible project for the Louisville Rotary Club to support that would have long-term positive benefits on the entire community. The Land Swap Agreement between the Louisville Public Library, the Louisville City Schools, and the City of Louisville is resulting in the Library acquiring the former old Middle School property bordered by East Main Street, Gorgas Street, Mill Street, and Church Street. In addition, the Louisville City Schools will receive the library-owned baseball field and parking lot on S. Chapel Street and the City of Louisville would receive a portion of the old Middle School property to construct a new fire hall in the not too distant future. Additional highlights of his presentation are as follows:

1. These discussions among the three entities have been going on for 8 to 9 months and have resulted in a win-win-win arrangement for all parties concerned.
2. By acquiring the former old Middle School property, the Library Board will soon begin plans for a new Community Center & Library. He estimates this will be a 3 to 4 to 5 year effort.
3. Plans are very preliminary now but the new Community Center would be approximately 5,000 square feet and the new Library would be 15,000 to 15,500 square feet. The Library Board would also take possession of the old Post Office which could be used for housing historical documents and artifacts of importance to this community. There will be ample parking for both the Community Center & Library as well as for City Hall business. This project would obviously be of benefit to the downtown commercial district.
4. The Library Board is committed to raising the \$3 to \$4 million needed through a private fundraising venture and by asking organizations, such as the Louisville Rotary Club, to ♦think about getting behind this project.♦
5. Mr. Anderson reminded everyone of the ♦Rotary Club Room♦ at the Salem (Ohio) Community Center that was funded by the Salem Rotary Club.
6. He also reminded everyone how successful the Louisville Rotary Club was when we took on the public restroom project at Metzger Park a few years back.

Cherye Casar spoke about a possible ♦nest egg♦ in the Rotary Club budget for a project of this nature.

In the closing minutes of Mr. Anderson♦s presentation, Jim Edwards remarked that a project of this nature is perfect for this club - ♦we can do this, guys!♦

President Fausnight indicated that we will discuss this matter further at the next Business Meeting, which will be held on Wednesday, December 1.

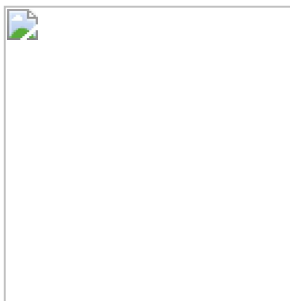

9. Program ◆ ◆Bernie Schrader: From Ohio to Rio in a Jeep to attend a Rotary International Convention in 1948◆ by his son Michael Schrader. Mr. Schrader spoke eloquently about his late father, Bernie Schrader, who lived his dream by waging world peace during the politically-charged era of the late 1940◆s. A summary of Mr. Schrader◆s presentation follows:

Back in 1948, Bernard Schrader, while acting on behalf of the Louisville Rotary Club, perused a map of the Western Hemisphere and decided that he would travel by Jeep from Louisville, Ohio to Rio de Janeiro, Brazil for the 39th Annual Convention of Rotary International. The purpose of the trip was to bring a message of peace along the way to Latin Americans - from shoeshine boys to national Presidents. Schrader's map showed the Pan-American Highway in 1948 linking North, Central and South America. However, when the intrepid, one legged traveler - he had a wooden leg as a result of tuberculosis - reached parts of Latin America, he found there were no roads where there were supposed to be roads. When he reached the Southern Mexico border, he discovered there was only one way to get to Guatemala with his Jeep: by railroad flat car. Two countries - Costa Rica and Columbia - were undergoing civil strife so he was forced to load his Jeep onto a C-46 freight airplane and fly over the area. In Argentina, he drove the Jeep along a cattle trail buried in snow for 100 miles. He traveled 200 miles between Uruguay and Rio Grande, Brazil, by way of Atlantic Ocean beaches because there were no inland roads through that area of the country. He reached Rio de Janeiro on May 15, 1948 and returned to Louisville by plane after a week at the Rotary convention.

The legacy of his trip is a treasured "log book" and three dozen photos that Bernie compiled during his travels. The log book includes messages of good will from half a dozen Latin American presidents and countless others he met along the way. The log book, which bears the Rotary Club emblem, was officially presented to the Louisville Rotary Club and it will be a lasting archival treasure for generations to come.
