- a. Betty Derry is happy the tickets for the Louisville-Nimishillen Historical Society s annual banquet (on Thursday, May 2) are selling so well. Still not too late to purchase your tickets!
- b. Betty Derry is also happy that the Louisville-Nimishillen Historical Society recently acquired some rare photographs of the old Post Office (inside and outside the building) during its building process in the early 1940 s.
- c. Mike Snyder is happy for the excellent photograph Denny Valentine took last week of our club saluting the two new flags outside the old Post Office.

9. Club news/Business

- a. Maranda Saling introduced Helen Stayer of the American Cancer Society. Ms. Stayer spoke briefly about the Relay For Life of Louisville/Alliance that will be held on Friday, May 31, 2013 from 6:00 p.m to 12 noon on Saturday, June 1. The main events are the lighting of hundreds of memorial luminaria and the closing ceremony. Each team member is encouraged to secure \$100 in pledges or contributions and their target is to have someone from a team walking the entire 18 hours. Like last year s Relay, this event will be held at the Marlington High School Stadium at 10450 Moulin Ave NE, Alliance, OH. - b. Ryan Heckert from the Stark County Board of Development Disabilities spoke briefly about the forthcoming vote on Tuesday, May 7. The agency serves approximately 3,300 people in such areas as Education, Life Skills, and Crisis Intervention. This vote will & combine two existing levies & a 1.9-mill that expires at the end of 2013 and a 1.4-mill that expires at the end of 2014 into one 3.3-mill tax issue. These are NOT new taxes!!! - c. Ken Smith mentioned that the flag partnership with local cemeteries is not feasible at this time. He also stated that he and Jim Edwards will be speaking before the Coshocton Rotary in the near future. Jim Edwards stated that \$5,000 in flag revenue has been received to date and that by May 1 he will ask for assistance in stuffing invoices for those who have not yet paid. There will also be a flag assembly party in the month of May and the first flag delivery will occur just before Memorial Day (May 27).
- d. Ron Derry said our club will conduct a farewell reception for the GSE group on Sunday, May 19 and we will have to ask our visitors about their dietary restrictions.
- e. Steve Roberts has agreed to serve on the Economic & Community Development Committee with Cynthia Kerchner who will be returning to Louisville in the near future.

- 1. Call to Order Meeting called to order by President David Yeagley with 23 of 46 members present.
- 2. Visitors and Guests: Gail Gress, Jason Pugh, Dana Rode
- 3. Updates
 - a. Flags should be returned by this evening. Please contact Ken or Dave.
 - b. Cynthia Kerchner indicated the Rotary will be sponsoring the Louisville Farmer Market August 10, Sept 7, October 5 from 8am to noon. To reserve a space (with free set-up) contact 330-875-9282. Please spread the word and more information will follow.
 - c. Maranda Saling said we have raised about \$1500 for Relay for Life. If you want to donate or walk tomorrow night, please contact her.
 - d. Flags for our Fathers lost funding. The club conducted an email vote and decided to donate \$200 to help place flags on the graves of our veterans.
- 4. Program: Al Gress The History of Paradise United Church of Christ (PUCC)
- a. Secretary Disclaimer: For the most accurate and detailed information, please buy Al so book available through him or the PUCC office for \$15. I did my best with the notes.
- b. PUCC is celebrating its 150th Anniversary this year. Greg Anderson swife, Jen is heading the celebration committee and Al and his wife Gail, are on the committee. Al was volunteered to write the history of PUCC and referenced the 100 year celebration research and Ken Smith s book.
- c. In 1802, Nimishillen Township was first recorded. In 1803, Ohio became a state. Lewisville applied for a post office and upon finding out there was already a Lewisville, became Louisville. We had a tavern (near the physical therapy place on Main St) in the early 1800s and our own brewery in 1865.
- d. Louisville was a blend of settlers and the Protestant contingent desired a place to worship (St. Louis was established approx. 25 years before PUCC). Abrahm Miller, a charismatic leader, held a worship service that gained popularity. They petitioned to be recognized as a church and became the German Reformed Church. Some services were done in German. In 1868, they bought land for \$300 (which some thought was too expensive). Building plans were made and the construction was faith-based. The

congregation donated labor, wagons, etc and they solicited money in Canton. The building was completed and contained an organ (controversial). Miller is considered the Father of Paradise Church.

- e. Dr. Liberman served from 1873 to 1900. In 1892, they rebuilt the church for \$10,600 and it was judged to be the finest architecture found in a church outside of a major city. Volunteers laid the sidewalk and the rose glass window was a donation. Services switched to English only. After facing opposition to abolishing members for not attending, Dr. Liberman resigned leaving the church with 375 members and no debt.
- f. In 1903, communion changed to individual servings instead of a communal cup. This caused controversy. In 1907, the church gained a \$3500 organ, which some members thought was the institute of the devil. They adopted Eastern Standard Time as the official time for services, which caused farmers to feel mistreated. The village council (primarily Catholics) told the church members they would have to clean up after their horses, that were hooked to the front of the church and defacing Main Street during the 2+ hour services. The congregation refused, but ultimately bought a lot for \$200 for the horses (presently the fenced in lot behind the brick house across the street). The alley way was made one way (as it is today) once automobiles created a traffic jam between services.
- g. In the early 1900s, the church sponsored Boy Scout Troop 44, which they still do today (and Al and Jim Edwards participated). Volunteers dug a basement in 1912 (currently the old kitchen). The church was rented for \$15 for the High School graduation. They also moved their cemetery from Washington St. to Union Cemetery. The Louisville Rotary met at the church, but left because they could not smoke after eating (although some did in the restrooms). In 1924, Paradise was first found in the records and the name (without vote) became Paradise Reformed Church. Many people stopped attending during the Great Depression because they were too poor to contribute and after the attacks on Pearl Harbor, the church donated their basement space to the Red Cross for training. Four Paradise men died in the War.
- h. Rev. Kaiser was the longest tenured pastor from 1955-1984. He added many features to the church including the Parish Paragraphs, the speaker system, the church library, the bell choir, and a \$425,000 addition finished in July of 1985. His wife Barbara and Jean Jackson worked to bring the first foreign exchange student to Louisville, hosted by the Jackson family. In 1957, after church mergers, Paradise became Paradise United Church of Christ.
- i. Rev. Krabill served from 1984 to 1992. He wanted to buy a computer but this was controversial. Together with Pat Smith, Ken Smith so wife, they established Kid Watch, an after school program still going today. The greater UCC supported gay rights in the mid1980s, but PUCC declined. This occurred again in 2006, but 83% turned support down. In 1987, E.C. Lair donated the organ.
- j. Dr. Roberts served from 1994-2008 and was great at getting people to work together. His Carpenters was formed, which is a group of volunteer men who provide services for the church (in keeping with the volunteer spirit as described above). Dr. Roberts started coffee hour, children so moments, the golf scramble fund-raiser, and Friday night football dinners. In 1999, the church underwent a renovation and addition that included air conditioning and an elevator. In 2004, they launched their website.

 k. The church is currently led by Rev. Joyce Schorer, whose diverse ministry background helps PUCC to continually define



- b. Betty Derry is happy they had help with their flag route and that there haven to been any more spiders.
- c. Cynthia Kerchner is happy her cousin, Theresa Cusma, is here.

- 5. Updates:
- **a.** Ken Smith said everyone is doing a great job with flags. Our next posting is July 1st and 2nd (or June 30th).
- **b.** Cynthia Kerchner reminded us that August 10th is the first farmers market.
- **c.** The Taste of Louisville is July 17th at the Water s Edge from 5pm to 7:30. Cost is \$6 at the door, and only \$5 if you bring a nonperishable food item for the Community Cupboard.
- **d.** Jim Edwards reminded us to check that we ve posted all the flags on our route. If we can t find a post, call Ken Smith.
- e. The Installation Banquet is Wednesday, June 26th with the cash bar starting at 6pm and dinner at 7pm. RSVP to Wendy Harlan with your meal choice (steak, chicken, fish, vegetarian) or let her know you cannot attend. The speaker will be Massillon s museum s Mandy Altimuspond and she will talk about the Titanic c complete with artifacts and pictures.
- 6. Program: Theresa Cusma, Exec. Director of Coleman Professional Services
- **a.** Theresa has been a mediator for the last 15 years and before that taught at Kent State (which she still teaches conflict resolution classes). Four years ago her practice merged with Coleman and they are now called Coleman Professional Services.

The business also recently acquired Trillum. This makes them the 29th largest non-profits in Ohio, but they do have consultation and data service sections that are for-profit in support of the non-profit. Ohio does not fund mediation. They operate in 7 different counties

- **b.** Coleman offers many products and services, one of which is mediation. There is a decrease in the quality of life from unresolved conflicts. These can be dealt with on a rights-based process (legality) and/or an interest-based process (perception). Mediation is creative and flexible and allows parties to say what they want to say.
- **c.** Coleman offers training to improve conflict resolution skills and their staff of 6 handles approximately 800 mediations a year. Their customer base is diverse, as they get cases from the courts, school districts, families, neighbors, and landlords. The Louisville School District will use their services starting next fall for truancy issues. They currently have an 80% agreement rate with these issues.
- **d.** By asking questions and understanding each other sperceptions, a shift of thinking occurs. It is very rewarding to have two adversaries work out their differences.
