Rudy is, himself, a Navy veteran and joined the Navy when he was 17. His Navy specialty was fire control and he served on a number of aircraft carriers. Along his career, Moyer was awarded three Bronze Stars. He has worked with disabled persons for 18 years. Among the other items on his resume is working the Stark County Hunger Task Force and is a member of the Ohio State University Extension Advisory Committee. Rudy grew up in the Hocking Hills area of Ohio. The horticulture program includes a half-mile walking path. Rudy told stories of the benefits of people growing plants and working with their hands in the soil.

A side of his program was his personal display of military memorabelia (not weapons) that he brought that filled 5 or 6 eight-foot tables. Just of few of his collection included a 48-star American flag, a WWII Civil Defense Helmut, numerous books detailing wartime actions; ration coupons and discharge papers for a Civil War veteran.



There is a commercial kitchen, but they do not do food preparation and they have a state-of-the art sound system. There is ample parking. The facility will rent for a half-day or a full day.

The owners of the property live on the grounds, but the offices for their company Forever Lawn, are in North Canton.

The company makes and installs artificial turf.



NAPA car batteries are the only batteries sold in the U.S.A. that are manufactured in the U.S.A. The store even has a log splitter for sale. About one third of our business is auto parts, he said. Our catalogue inventory on the computer can find auto parts going back to 1900. John said the store has parking behind the store and there is a rear entrance. Store hours are 8 to 6 Monday through Friday, 8-5 Saturday and 10-4 on Sunday. Their phone number is 234-252-9601.
